Amendment Report Public Exhibition - 70% public support for the project

WinterbourneWind recently lodged the Amendment Report with the NSW Department of Planning, Housing and Infrastructure (DPHI).

The report laid out the improvements to the proposed wind farm since the original Environmental Impact Statement (EIS), based on further design and assessment and after engagement with the community, landholders and Councils to harness local knowledge.

Key improvements included a change in the transport route to use Thunderbolts Way, an on-site quarry to reduce traffic, and shifting some turbines and tracks to reduce impacts to the environment and improve constructability. There were 394 individual and local organisation submissions (excluding duplicates), as well as submissions from local councils and government agencies. The results from the public exhibition period are shown in the table below. **The feedback received was overwhelmingly positive, with 70% of public submissions indicating support for the proposed project.**

We thank everyone who made a submission about the project whether for or against it - it's important that local voices are heard.

The public support shown for the Project mirrors the recent results from a survey conducted by Farmers for Climate Action. This survey found that 70% of regional Australians in renewable energy zones support the development of renewable energy projects on local farmland. That survey also found that support for renewable energy developments increased to 73% for people connected to the farming industry.

We are also undertaking assessment and design of public road upgrades in consultation with Walcha and Uralla Shire Council staff.
